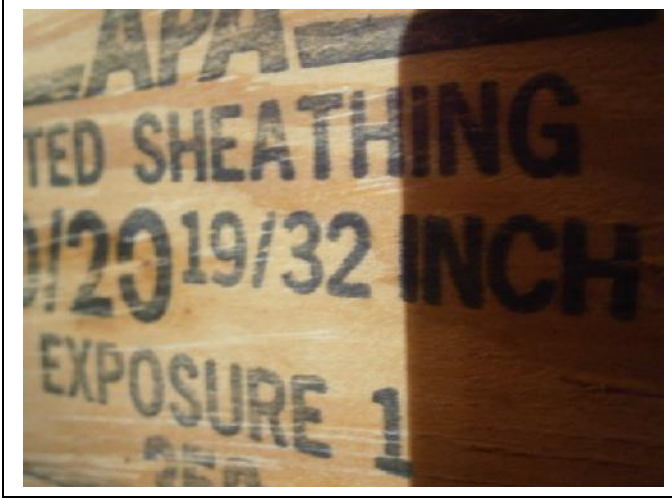

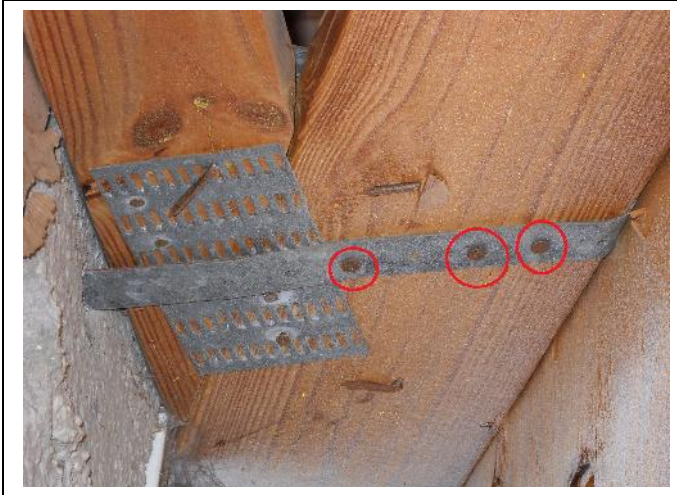

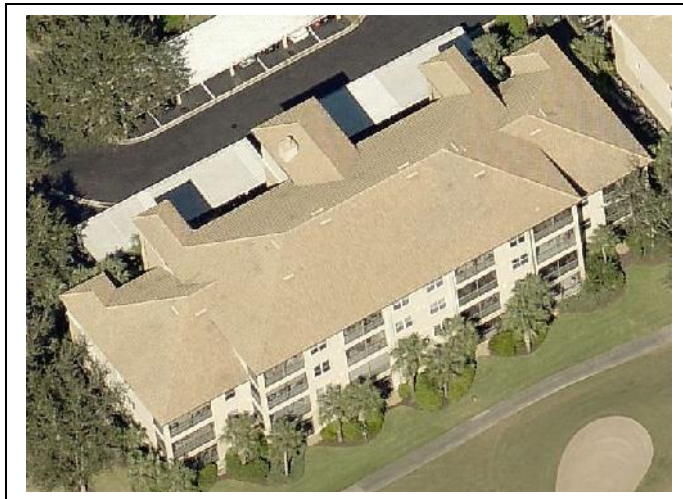

## Hammock Greens I, II, III and IV Reroof Specifications

March 18, 2016

**3.02 Fastening of the Decking** - The existing plywood decking shall be re-nailed to the rafters/trusses 6" on center along the edges and 6" on center in the field area of the plywood. Nails to be minimum 8d ring shank. *See Detail Drawing PLWY-1 / Hammock Greens I, II, III and IV*

**Underlayment Installation - Polystick MTS** - shall be installed per manufacturer's requirements and be back nailed 12" on center in the horizontal lap. The first course roll shall be cut in half (18") so that the horizontal laps of the Polystick TU Plus are staggered (hitting approximately in the middle of the MTS). The MTS shall be taken under the existing L metal at headwall and sidewall areas. All rolls must be broomed in with a stiff bristle broom. *See Detail Drawing UDL-4 / Hammock Greens I, II, III and IV*

**NOTE #1: THE FIRST PLY OF UNDERLAYMENT MUST BE INSTALLED WITH 1.5" TO 2.25" OF THE MEMBRANE LAPPED OVER THE ROOF EDGE AND DOWN THE FASCIA AND OR GUTTER.**

**NOTE #2: SHOULD THE DECK BE OSB ... THE CONTRACTOR MUST USE PRIMER PER UNDERLAYMENT MANUFACTUER'S SPECIFICATIONS**

**3.03 Valley Underlayment** - One layer of Polystick MTS shall be installed vertically up all valleys centered over the valley prior to the installation of the Polystick TU Plus.

### 3.04 Drip Edge Metal Installation

- A. The drip edge metal must be primed with ASTM D 41 asphalt primer. Please note caution must be taken to avoid spillage of the primer down the face of the metal.
- B. The drip edge metal shall be fastened 4" on centers with minimum 1.25" long ring shank stainless steel nails. All joints of the drip edge shall be **lapped a minimum of 4" and sealed with polyurethane caulking.**  
*See Detail Drawing DE-2 / Hammock Greens I, II, III and IV*

**3.05 Underlayment Installation/ top ply** - The top ply of the underlayment, the Polystick TU Plus shall be then installed per manufacturers requirements and back nailed 12" on center in the horizontal laps. The TU Plus will also be installed under any existing L metal. *See Detail Drawing UDL-4 / Hammock Greens I, II, III and IV*

**3.06 "L" Metal Installation (where applicable)** - Once both plies of the underlayment have been taken under the existing L metal, the L metal shall be reset in a bed of SBS roofing cement and nailed in place 4" on center with stainless steel ring shank nails long enough to penetrate the underside of the deck by at least 1/2".
